In the event that buyer can no longer care for said dog, Buyer agrees to contact seller immediately so they can assist in finding a suitable home.

Seller offers buyer full opportunity to take their new pet to a veterinarian of their choice within 72 hours of the date of purchase. This will fulfill contract. If no exam is performed within 72 hours of purchase said guarantee becomes NULL and VOID.

Seller DOES NOT pay vet expenses of any kind.

We are not liable for any internal or external parasite including but not limited to ear mites, fleas, etc. these are all common things that can plague any animal at any time. To the best of our knowledge, Oakhill Kennel, this puppy is free of all parasites at time of purchase. This puppy is up to date with the vaccines and deworming as to age of puppy.

If puppy received their vet exam within the 72 hours as stated above and this guarantee has been signed by buyer and returned to seller within 10 business days of purchase date said dog is guaranteed for 2 years against LIFE THREATENING CONGENITAL DEFECTS. We DO NOT guarantee against: skin, ear, knee, elbows, eyes or hip issues. Nor do we guarantee against- HYPOGLYCEMIA. We do not guarantee against puppy diseases as you must keep vaccines up on your puppy.

For the Chinese Shar-pei, we do not guarantee said puppy will not have to have another eye tack or entropion surgery. This is just part of the breed.

If said puppy is found to be sick with LIFE THREATENING CONGENITAL defect by a licensed veterinarian that the buyer were not made aware of at time of purchase, We reserve the right to have our veterinarian have the final determination on the findings

If in the event that it is determined that said dog does in fact have a life-threatening defect within 2 years of purchase, we agree to replace dog. NO CASH REFUNDS ARE GIVEN—NO EXCEPTIONS.

If the only replacement dog available at the time is of a higher value buyer may pay the difference or reserve their right to wait for another litter to arrive for their replacement. Seller has up to a year to produce a replacement puppy.

Before replacement puppy will be given the original paper work must be returned to me.

In a case where the dog has become deceased within 2 years of purchase there must be a necropsy performed by a licensed vet. A copy of any and all findings must be received, and my vet will determine if a replacement is justified.

If a replacement dog is due it is the sole responsibility of buyer to pay for any and all travel and delivery costs on the replacement's arrival.

WE DO NOT guarantee against any illness that was contracted after leaving my facilities.

It is understood that this is a legal and binding contract between buyer and seller.
